Program Co-Chairs

Edward S. Allen has handled condemnation matters during the majority of his 43 years of practice. He is also engaged in commercial litigation, including public utility, contract, civil rights, riparian rights and real property matters. He served on the Alabama Law Institute's Eminent Domain Law Revision Committee through the period in which the committee drafted the Alabama Eminent Domain Code, adopted by the Alabama Legislature in 1985. Since the enactment of the Code, he has continued to serve on the Institute's Eminent Domain Law Committee.

Warren C. Herlong, Jr., has spent a majority of his 28-year general civil litigation practice focusing on condemnation, where he has represented agencies and owners with a predominance in owner representation. He served for three years as co-chairman of the American Bar Association's 58,000-member Section of Litigation, Committee on Condemnation, Zoning and Land Use. He is the Alabama representative in the Owner's Counsel of America, a Miami-based organization of one lawyer per state who primarily represents owners in condemnation actions. Mr. Herlong practices condemnation statewide in Alabama.

The Honorable Michael F. Bolin was a practicing attorney in Birmingham from 1973 through 1988, when he was elected Probate Judge of Jefferson County. He served in that position until his election to the Alabama Supreme Court in 2004, and began serving as an Associate Justice on that Court in January 2005. He was active in the Alabama Probate Judges' Association, where he served as President, Secretary, and Treasurer.

William M. Bouldin is a private practice condemnation law attorney. He previously served as an attorney for the City of Russellville for over 20 years. In 1995, he was appointed as the Deputy Attorney General of Alabama to work on condemnation proceedings.

James A. Bradford has over 25 years of experience in representing individuals and companies in a wide range of litigated matters involving contract, eminent domain, environmental, insurance, landlord/tenant, product liability, professional negligence, real estate, tort, and wills and estates law.

Isaac P. Espy is a patent attorney who practices natural resources law, real estate law and construction law. He is a licensed professional land surveyor and a licensed professional engineer.

Jesse P. Evans is a real estate litigation attorney. His practice includes all phases of development, construction, disputes, condemnation, land use, and zoning and ownership. He is the author of *Alabama Property Rights and Remedies, Third Edition*, and is an Adjunct Professor at the University of Alabama School of Law.

The Honorable Patricia Yeager Fuhrmeister has been the Probate Judge of Shelby County, Alabama, since January 1995. She was formerly the Chair of the Alabama Probate Judges' Association Committee on Continuing Education, and she is a lecturer at various CLE events in the field of probate law and procedure.
