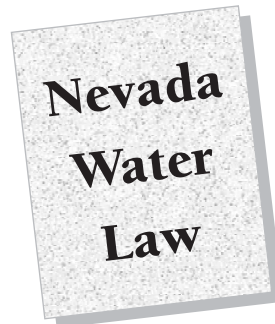

James H. Davenport also serves as Special Deputy Attorney General for the State of Nevada. He is the author of *Nevada Water Law* (2003). He was Associate Counsel for the Environment and Public Works Committee of the U.S. Senate and has served within the Attorney General's offices of Nevada and Washington state. While in private practice, he focused on environmental, water, energy, real estate and administrative law.

John Entsminger serves as Deputy Counsel to both the Las Vegas Valley Water District and Southern Nevada Water Authority. He practices in the areas of water rights and environmental law, including issues related to the Colorado River and intra-Nevada water resources.

Marta Adams has dedicated her professional life to environmental issues. She has practiced law for 28 years and has represented public and private clients with an emphasis on environmental, land use and water law issues.

L. Michael Bogert is Of Counsel in his firm. His practice consists of environmental and natural resources law, as well as government relations and public policy. He was most recently Counsel to Idaho Governor Dirk Kempthorne.

Kay Brothers was appointed to her current position in 2002. Previously, she served as director of SNWA's Resources Department, where she managed planning activities to protect existing water resources and to acquire future resources.

Adriana G. Fralick joined the Nevada Commission on Ethics in February 2005 in conjunction with the opening of the Commission's southern Nevada office in Las Vegas.

Terry Fulp is the Area Manager of the Boulder Canyon Operations Office of the Bureau of Reclamation, and is responsible for water operations, water and power contracts, water accounting, and water conservation, from Lake Mead to Mexico.

Douglas L. Grant is the Cord Foundation Professor. He teaches Property, Real Estate Finance and Water Law. He is the co-author of *Water Law: Cases and Materials* (WestGroup) and a contributing author of *Waters and Water Rights* (Matthew Bender).

Jon Hutchings is a hydrologist by training who is deeply involved in natural resource and public land concerns across the state. His chief pursuit is a sustainable economic and natural environment for Nevada's rural communities.

Lee Kapaloski is a shareholder in the environmental, energy & natural resources department of his firm and concentrates his practice on water law. He is a board member of the Utah State Bar, and has served on the Board of Directors of Western Network.

Brent T. Kolvet handles water cases, civil rights cases and has acted as special prosecutor in two capital murder cases. He previously served as the elected District Attorney of Douglas County from 1982 until 1991.

John L. Marshall is General Counsel to the Tahoe Regional Planning Agency ("TRPA"). In that capacity, he advises the Governing Board of the TRPA and oversees litigation concerning efforts to preserve and protect Lake Tahoe that often alter the use and value of private property.

Robert W. Marshall joined his firm after more than 35 years with Vargas & Bartlett. He is widely experienced in public utility law and water rights law of Nevada and the Colorado River System. He was one of the principal drafters of the documents creating the SNWA.

Sara A. Price is in private practice and provides consulting services to the Colorado River Commission. Previously, she was a Senior Deputy Attorney General with the Nevada Attorney General's Office.
