# meet your **instructors**

**Paul Beveridge** started Wilridge Winery in 1988, three years after he graduated from Columbia University School of Law. His winery is best known for producing award-winning single vineyard red wines from grapes grown at premier locations in Washington State. Current production is limited to Washington State Cabernet Sauvignon, Merlot, Syrah, Nebbiolo, Semillon and Viognier. His wines have received multiple medals and high ratings from wine publications.

In 2002, Paul conceived and co-founded the Wines of Washington Tasting Room in Seattle's famous Pike Place Market. His Tasting Room is the first and still the only cooperative wine tasting cellar in Washington State. It features over fifty wines from six boutique wineries, including Wilridge. Paul's legal training was invaluable in obtaining government approval of the Tasting Room.

Paul is a shareholder at Heller Ehrman White & McAuliffe, where he practices a wide variety of regulatory law, including representation of winery and brewery clients in matters of business start up, regulatory compliance, labeling, legislation and trademark. Heller Ehrman is a global law firm with offices in thirteen cities and over 700 attorneys worldwide. Paul is the head of Heller Ehrman's "Wine Team," which represents large and small wineries in the United States. Paul is also a board member of the Washington Wine Institute, the Washington State wine industry trade association.

Paul resides in Seattle with his wife Lysle Wilhelmi (the "Wil" in Wilridge) and their two young sons. Until 2003 they lived above the winery in the Madrona neighborhood of Seattle. Paul's retired parents now live above the winery with their black cat, Pinot Noir.

**Corbin Houchins** is a member of Graham & Dunn's Hospitality, Beverage & Franchise Team. His practice emphasizes production, distribution, and retail sale of licensed beverages and protection of licensed beverage trademarks and domain names. He also has long experience in contractual, antitrust, and regulatory aspects of marketing all brand name goods and services, including Internet transactions and franchising.

Corbin held the position of corporate counsel for E & J Gallo Winery and for Olympia Brewing Company, with responsibility for trademark, copyright, patent, and trade secret protection programs, for antitrust counseling, and for legal compliance in packaging and distributor relations. He is the author of numerous articles on licensed beverage law, intellectual property and distribution law for CLE manuals and business publications, and is the Chair of the Washington State Bar Association's continuing education program on distribution law.
