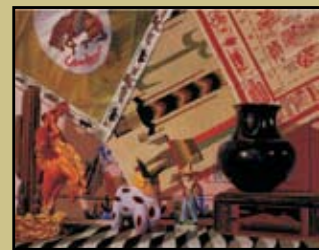

Brooke Oliver represents artists, activists and entrepreneurs in art, copyright, and trademark litigation and transactions. Her clients include the Jerry Garcia and Nina Simone Estates, the Dolores Huerta Foundation, Sony Computer Entertainment, Michael Parkes, Eyvind Earle, Judith Baca, Burning Man and San Francisco Pride.

Featured Speakers

Aaron M. Milrad is an art collector who also serves as an eminent Canadian arts and culture lawyer. In 1999, he gifted one of the most important collections of international contemporary ceramics in Canada to the Gardiner Museum in Toronto. He draws on his experience as a collector and attorney to advise clients about their own collectibles; import and export of art; donation programs; and issues for artists, architects and authors.

William F. Shepherd creates a unique look into the reality of our modern multicultural society by juxtaposing handmade objects that speak about the culture from which they came. His most recent exhibition, *Reviewing the West*, has been displayed at the Gerald Peters Gallery® in Santa Fe and the Nicolaysen Museum & Discovery Center in Casper.

Faculty Members

Tsan Abrahamson focuses on intellectual property, advertising, trademark and copyright clearance and prosecution, licensing and other business transactions. She previously served as the worldwide Intellectual Property and Licensing Counsel at LeapFrog Enterprises.

Dianne Borsini-Burr started her first gallery in 2001 and quickly opened a second gallery. She has spent the past seven years mentoring and promoting artists, as well as showcasing great art. She has a background as an entrepreneur involved in accountant staffing and real estate development.

Susan B. Bruning heads a boutique practice focused on entertainment, fine arts, antiquities and cultural heritage. She has been an adjunct professor of law for 15 years, teaching Art & Antiquities Law, Entertainment Law, and Law & Archeology.

Gilbert S. Edelson concentrates his practice in the representation of clients in the visual arts. He is Vice President of and Counsel to the Art Dealers Association of America. He is a trustee of both the Archives of American Art of the Smithsonian Institute and the New York Studio School.

Pieter Arend Folkens is a biomedical illustrator best known for his work in marine mammals and human osteology. He designed and sculpted the anatomy of such memorable cinematic cetaceans as the humpback whales in *Star Trek IV*, the killer whales in the *Free Willy* series, and dolphins for *Flipper* (the movie), *White Squall*, *SeaQuest DSV* and others.

Janet Fries leads her firm's copyright practice group. She has represented numerous authors, artists, collectors, estates, art organizations, musicians, producers and Internet companies. She is a board member of the Washington Area Lawyers for the Arts and an experienced professional editorial and fine art photographer.

Ann M. Garfinkle represents visual artists and writers, as well as the estates of artists and collectors, including the estate of Morris Louis. She is also a member of the Executive Committee of the Board of Trustees of the Maryland Institute College of Art, a founding director of International Network for Conservation of Contemporary Art and a member of the DC Estate Planning Council.

Charles B. Goldstein is a forensic art appraiser. He has earned the designations "Certified Appraiser of Personal Property (CAPP) in Fine Art" and "Certified Appraiser of Personal Property (CAPP) in Limited Edition Prints" from the International Society of Appraisers and is the Fine Art Chair for that Organization. He has over 25 years of fine art appraisal and dealer experience.

Robert A. Horn has over 30 years of experience practicing art law and entertainment law. He is also a collector of late 19th-century and early 20th-century American art and American prints. In April 2006, he spoke for the International Society of Appraisers on the "Role of Appraiser in Protecting the Client from Dispute Valuation and Litigation."

Linda Joy Kattwinkel is a visual artist who also practices intellectual property and arts law for corporate clients, as well as individual artists and designers. She has been mediating and arbitrating arts related disputes since 1987.

Peter E. Lippett has been practicing estate planning and trust law for 44 years. He represents several artists and artists' estates. He has lectured extensively, has authored two books on estate planning, and is a member of the San Francisco Estate Planning Council.

Alice Tomlinson Lorenz focuses on appellate law, commercial, complex and class action litigation, professional liability and personal injury. She is a former member of the New Mexico Commission on Professionalism, the ABA Commission on Impaired Attorneys and the Lawyers' Assistance Committee. She received the *New Mexico Law Review* Excellence in Jurisprudence Award in 2005.

James Martin founded his materials analysis and consulting firm and specializes in the examination and analysis of cultural property. He has undertaken more than 1,300 investigations for museums, collectors, law firms and insurance companies.

Ann McMullen focuses on policy development, intellectual and cultural property and rights management, collections research and collecting issues. She has worked in museums since 1978, including as the head of Anthropology at the Milwaukee Public Museum.

Marc David Paisin co-founded California Lawyers for the Arts in 1973 after completing his dual media M.F.A. in metal smithing and glass blowing. His clients have included the Natural Science Illustrators, Association of Medical Illustrators, Society of North American Goldsmiths, Graphic Artists Guild, HESCA and Society of Western Painters. He currently maintains a full time practice as a mediator/arbitrator, with a continuing consultation practice in art law.

William G. Pearlstein focuses on regulation of international transfers of cultural property. He represents both private dealers and collectors of fine art and antiquities. He has represented Sotheby's in connection with proposed restrictions on Chinese artworks and with a prominent antiquities dealer in generating a policy proposal to a leading business think tank.

Grant B. Romer has been with his organization since 1975. He became the photograph conservator in 1978 and has contributed to the professional development of many of the international leaders in his field today. He is known worldwide as a lecturer and author.

Katja Zigerlig oversees the strategic growth of the fine art, jewelry and wine insurance portfolio of her company. She has over a decade of professional experience in the art world and holds a masters degree in art history. She is a member of the Young Collectors Council at the Guggenheim Museum.
