Charles T. DuMars is a member of Law and Resource Planning Associates, a law firm practicing resource law not only in New Mexico, but in other states and internationally. He is also Professor Emeritus at the University of New Mexico School of Law.

John W. Hernandez is currently Professor Emeritus at NMSU. He was Dean of the College of Engineering at New Mexico State University from 1975-80 and Deputy Administrator for the U.S. Environmental Protection Agency from 1981-1983.

Victor Kovach is an administrative hearing examiner for the Office of the State Engineer and has presided over numerous water rights hearings, including those concerning the City of Albuquerque's Application for diversion of San Juan-Chama Project water, among others

John W. Longworth oversees his Agency's conservation program, subdivision review section and the development of consumptive irrigation requirements. Previously, he was a project engineer for the New Mexico Interstate Stream Commission, Pecos River Bureau.

Jolene L. McCaleb has been representing clients on water issues, including water quality rulemakings, for more than six years. Previously, she worked in Phoenix, where she served one year as a law clerk to the Arizona Supreme Court.

J. Brent Moore focuses primarily on enforcement actions, rulemaking, and permit proceedings in the areas of surface water, ground water, hazardous waste, and solid waste.
