H. Bradley R. Cahoon practices litigation, administrative and regulatory law and government relations in the areas of environmental, water, zoning and land use, natural resources and utility law.

Steven E. Clyde is a shareholder and managing director of his firm. Throughout his 30 years of practice, he has specialized in the practice of natural resources law, including oil and gas, public land law, and mining law with a primary emphasis in water law.

Wendy Bowden Crowther practices primarily in the areas of natural resources and environmental law with an emphasis on water law. She has represented municipalities, water districts, irrigation companies, and individual water right holders.

Daniel A. Jensen represents developers, ranchers, municipalities, service districts, businesses, irrigation companies, ski resorts, lenders, utilities, manufacturers and individuals with regard to, among other things, acquisition and transfer and modification of water rights.

His responsibilities include providing environmental-related consulting services encompassing a wide range of projects from soil, groundwater, and hazardous waste investigations to evaluating Superfund Liability associated with property transactions.
