### Program Chair

He also wrote a chapter entitled "Trial Tactics and Strategies in the Presentation of Comparable Sales" for the treatise *Nichols on Eminent Domain*.

**Brian P. Patchen** has practiced in the area of eminent domain for over 30 years. Before starting his own firm, he worked for three years for Morgan Guaranty Trust Company on Wall Street.

**Keith L. Williams** has been with his organization since 2002. He was formerly with the Palm Beach County Attorney's Office.
